<p>Deposit refund</p>	<p>In order to be entitled for a deposit refund, a written withdrawal form must be submitted to the parent liaison officer.</p> <ul style="list-style-type: none"> ▪ Sufficient notice of 8-weeks prior to the child’s last day at school must be given in order to be entitled for a full deposit refund. ▪ In the case of insufficient notice or the notice form is not submitted 8-weeks prior to the child’s last day, 50% of deposit will be forfeited.
<p>Tuition fee refund in case of withdrawal</p>	<ul style="list-style-type: none"> ▪ The parent is eligible for no refund of Term Tuition fees. ▪ In order to be entitled for a Annual Tuition fee refund, if at the time of the child’s withdrawal, there is: <ul style="list-style-type: none"> ▪ 75% and above left of the school term, then the parent is eligible for a 50% refund of the tuition fee. ▪ From 50% to less than 75% left of the school term, then the parent is eligible for a 25% refund of the tuition fee ▪ Less than 50% left of the school term, then the parent is eligible for NO REFUND of the tuition fee. ▪ <i>All withdrawal fees will be subjected to relevant discount, deductions which the child was previously entitled to.</i> ▪ <i>Discounted tuition fee according to special promotion is nonrefundable.</i>
<p>Tuition fee deduction to next term for holidays during school days</p>	<p>If the holiday is less than 10 school days or without notice, NO REFUND of tuition fee.</p> <p>In order to be entitled for a tuition fee deduction for holidays during school days, a written Holiday form must be submitted to the parent liaison officer. Deadline to submit written Holiday form is the first day of Holiday</p> <ul style="list-style-type: none"> ▪ For full deduction entitlement, <ul style="list-style-type: none"> i) a minimum notice of 10 school days is required, ii) a minimum holiday period of 15 school days is required ▪ If the holiday is from 10 school days and above or you have given insufficient notice, your account will be credited 50% of tuition fee.
<p>Tuition fee deduction to next term for sickness during school days</p>	<p>If the absence due to sickness is less than 10 school days and/or without the doctor note or medical book from the hospital or medical clinic, NO REFUND of tuition fee.</p> <p>In order to be entitled for a tuition fee deduction for sickness during school days, a written Sickness Absence form must be submitted to the parent liaison officer with the doctor note or medical book form hospital or medical clinic. The absence period will be calculated from</p>

	<p>the date that Sickness Absence form is submitted.</p> <ul style="list-style-type: none">▪ For full deduction entitlement<ol style="list-style-type: none">i) A latest notice on the written date on the doctor note or medical book.ii) A minimum absence period of 15 school days and above is required.▪ If the absence period is from 10 to 14 school days, 50% of tuition fee will be deducted on the next term tuition fee.
Force majeure term	<p>Force majeure refers to all the events which objectively happen such as earthquakes, storms, floods, fire or any other natural disasters which are not listed here but which would include epidemic diseases, national emergencies, war, unforeseeable political state events these are beyond the school's reasonable control and therefore the teaching and learning activities cannot be carried out as normal. In the case of force majeure, the school has the right to temporarily close the school according to the laws of the Ministry of Education and Ministry of Health for the children's health and safety, after adopting all the necessary measures for the safety of the children and without any obligation to refund the tuition fees.</p>
